## Swimming School Policies for Summer Camps

### Enrollment and Fees

Students are only enrolled into the weekly sessions they are registered for and are not automatically reenrolled into subsequent camp sessions. The student's spot in the desired class is reserved once the availability is confirmed and tuition fees and necessary fees are received. **The \$50 registration fee is non-refundable. Registration fees will be waived for sign-ups before April 15<sup>th</sup>.**

### Withdrawals / Cancellations

Written requests/cancellation form must be completed at the swimming facility. Cancellation form is available. **Please keep a copy of the cancellation form request for your records.** There will be a \$50 fee for all cancellation requests if the cancellation request was received over one month prior to your session's starting date. **If the cancellation was received within a month of your session's starting date, no refund will be given back. \$20 change the schedule fee will be applied.**

### Missed Classes and make-up Policy.

**For missed Swim Lessons there will be a free swim practice/Swim Pass (no instructors) offered for missed classes. You will be issued a free-swim coupon for a missed class.** Swimmers under the age of ten must have an adult accompanying the student for their make-up practice.

**Private swim camp: for missed classes, you will be scheduled during a Summer Camp regular session.**

**We will not mix/combine any Summer Camp with regular classes.**

### Minimum Booking / Registration Fee

Students who enroll into any weekly camp sessions in progress must sign up for all classes remaining in that session.

### Scheduling

Saratoga Star Aquatics will make all efforts to schedule swimmers for preferred times but cannot guarantee availability. Saratoga Star Aquatics will make all efforts to keep instructors consistent for any given class but does not guarantee it. **Refund requests due to a substitute instructor will NOT be honored.**

### Change Classes

If you would like to change the time of your class, Saratoga Star Aquatics will make all efforts to reschedule swimmers for preferred times based on the availability of the classes. **\$20 processing fee will be applied for any more changes within one month.**

# Saratoga Star Aquatics Indoor Aquatics Center Liability Form

## Release and Waiver of Liability and Indemnity Agreement

**IN CONSIDERATION** of being permitted to utilize the facilities, services and programs of the Saratoga Star Aquatics Indoor Aquatics Center (or for children to so participate) for any purpose, including, but not limited to observation or use of facilities or equipment, the undersigned, for himself or herself and such participating children and any personal representatives, heirs and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the Saratoga Star Aquatics Indoor Aquatics Center for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgment that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation by the undersigned and such children.
