➤ **Enrollment and Fees**

The class rate is \$250.00. Students must pay in full with Check Only at time of enrollment to reserve placement in course. The student must show proof of Age at time of payment/enrollment that student will be at least 15 years old by the last day of the course.

➤ **Withdrawal/Cancellation**

Course will be cancelled and a full refund issued if there are less than 4 students enrolled within 48 hours of course start date.
 50% refund will be issued if student withdraws 8 days or more prior to beginning of course.
 No refund 7 days or less of the course start date if student withdraws regardless of when the student enrolled.
 No refund if unable to pass the pre-test and student will be dropped from the course.
 No refund for withdrawing once course begins.
 Student will be dropped if late or misses any of the course WITHOUT REFUND.

➤ **Pre-test and certificate test**

To obtain the American Red Cross Lifeguard Training/CPR/AED/First Aid certification:

Pass Pre-test on first day – failure to pass will result in student being dropped from course with no refund/credit:

- Swim 300 yards continuously.
- Tread water 2 minutes without use of hands.
- Swim a timed event in 1:40: swim 20 yards, retrieve 10lbs brick from deep water, swim back with brick, exit pool

To achieve certification:

- Pass pre-test
- Attend all course days and times.
- Pass written and practical exams

➤ **Medical exception**

In the event of a medical illness/injury, a credited for the course will be available with SSTA provided a note from a Health Providers states the student inability to continue to participate in the course. The student can use this credit towards the next course at SSTA.
